

ARBY'S GREEK GYRO GAMES SWEEPSTAKES OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. The Arby's Greek Gyro Games Sweepstakes (the "Sweepstakes") is governed by these official rules (the "Official Rules"), and is subject to all applicable U.S. federal, state and local laws, and is void wherever prohibited by law. **Odds of winning depend on the total number of eligible entries received.**

1. You must submit your email address when prompted at the end of the game. Eastern Time shall control for all purposes of this Sweepstakes. In the event of a dispute, the entrant will be the person whose name was entered in the appropriate area within the Sweepstakes.

4. WINNER SELECTION: The first three (3) people to complete the game and submit their email address will be notified as a potential winner at the email address they provided. Potential winning entries are subject to verification by Sponsor.

5. WINNER NOTIFICATION: Potential winner(s) will be contacted by August 31, 2020 at the email address they provided. Potential winner(s) must supply valid U.S. mailing address by September 14, 2020. If no email or mailing address is provided, the potential winner is disqualified and an alternate winner will be selected.
